

**THE AGREEMENT FOR COLLECTION OF FOREST WASTE
PRODUCTS AT SAO HILL FOREST PLANTATION**

BETWEEN

TANZANIA FOREST SERVICES AGENCY(TFS)

AND

MUFINDI WOOD PLANTATION AND INDUSTRIES LIMITED

MAY, 2019

2. COMPARTMENT/PLOTS FOR COLLECTION OF FOREST WASTE PRODUCTS

- 2.1 That, the Permit Holder shall engage into collection of forest waste products to the compartment/Plots designated in the Plantation by the Agency for such purpose.
- 2.2 In accordance with the compartments/plots allocated for harvesting of trees timber or other purposes and return of the same to the Plantation Manager after harvesting completion, the Permit Holder may be granted the said compartments/plots for collection of forest waste products by licence or permit issued for such purpose.
- 2.3 That, the Permit Holder shall not be allowed to collect forest waste products other than the compartment/plot stipulated in the permit, the violation will amount to a fundamental default lead to cancellation of the permit granted.
- 2.4 The Agency shall monitor the performance of the Permit Holder at the time or during the event of collection of forest waste products to ensure that the same is done in conformity to this Agreement.
- 2.5 The Agency shall have the right to enter to the designated compartments /plots to which the collection of forest waste products is done to check for the compliance of the terms and conditions of this Agreement and the permit granted for such purpose.

3. COLLECTION AND REMOVING OF FOREST WASTE PRODUCTS

- 3.1 The Agency shall allow the Permit Holder, his employee or Agent, to enter into allocated compartment/plots for collection of forest waste products.
- 3.2 The Permit Holder may carry out collection operation in the presence of a Forest Officer who will verify the quantity or, volume of forest waste products collected in a particular compartment or plot.
- 3.3 The collected forest waste products shall be removed from the designated compartment/plots under the cover of a Transit Pass in the form stipulated in the Fourth Schedule of the Forest Regulations of 2004 as amended from time to time.

4. THE FEES AND OTHER CHARGES

- 4.1 The Permit Holder shall pay collected forest waste products on the rates of royalties and other charges stipulated in the XIV Schedule of the Forest Regulation of 2004 as amended from time to time.
- 4.2 In the event of changes of royalties and other charges as per amendment of the Forest Regulation stated in clause 4.1 above, the Agency shall notify promptly the Permit Holder and the same shall take effect from the date of commencement as shall be indicated in the Government Gazette.

5. TERMS OF PAYMENT

- 5.1 The Permit Holder shall pay promptly to the Agency all royalties and other charges stated in Clause 4.1 of this agreement upon notification for total amount to be paid through the Government Payment Bill.
- 5.2 The Permit Holder shall, throughout the tenure of the license granted for the purpose and to this Agreement, pay the royalties fees for forest waste products collected to the Agency through Government Electronic Payment Gateway (GePG) via Control Number availed for such purpose.
- 5.3 The payment shall be made into Bank Account of the Agency and submit Bank Pay Slip to the Agency's Office before removing of the forest waste products from designated compartment/plots.
- 5.4 The review of this agreement will be at the option of the Agency if deem fit to do so depending on circumstances prevailing at the due time.

6. TERMINATION OF THIS AGREEMENT

This Agreement will be terminated in line with the expiry or cancellation of the License granted, upon occurrence of any of the events specified hereunder.

- a) If the Permit Holder fails to observe conditions specified in the License granted for the purpose and the terms/conditions specified in this Agreement.
- b) If the permit granted for collection of forest waste products will be cancelled due to default in conditions stated therein.
- c) If the Permit Holder fails to make registration as a forest product Dealer as stipulated in Regulation 54 (1) of the Forest Regulations of 2004 and thereafter apply for permit for collection of waste product as per section 49(1) (b) of the Forest Act, Cap. 323.
- d) If the Agency observes that, no more availability of compartment/plots suitable to be designated for collection of forest waste products.
